## 8-10-10 25% XCU Plus Micros

**Directions for Use:** Apply only as directed. Use in accordance with recommendations of a qualified individual or institution such as but not limited to a certified crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan

**Landscape Beds:** Apply fertilizer around the drip line of palm trees and tropical plants. 1lb. covers approximately 120 sqft. Reapply every 3 months for best results during the growing season. Spread throughout entire planting beds to cover all tropical plants and shrubs.

**Container Plants:** Sprinkle 1 tsp. per gallon size plant or 1 tsp. per 1-2 feet of height.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your landscape beds, and sweep any product that lands on the driveway, sidewalk, or street back into the bed. This product may stain driveways, walkways, streets, porches, and other non-target areas.
