MIX OR AGITATE THOROUGHLY BEFORE USE

APPLICATION TYPE: Soil Applied

RATE: 1 pint to 1 gallon per acre per application in a minimum of 5 gallons of finished solution.

GENERAL RECOMMENDATIONS: Apply at planting in seed furrow, T-banded, direct spray to seedbed, bare root dip or transplant drench. After planting apply to soil by methods such as drip irrigation, in furrow, side dress or direct spray onto beds.

TIMING: Soil or bare root applied at planting followed by subsequent applications at intervals of 2-4 weeks as needed for optimal soil conditioning, and overall improved plant vigor and maximized crop potential.

Directions for Use: PhycoTerra® fully mixes in water and is suitable for use in liquid soil applied and irrigation applications. Application at planting can be in the seed furrow, T-banded, sprayed onto seedbed, or as a bare root or transplant drench. After planting, PhycoTerra® can be applied via drip irrigation, sidedress, in furrow, direct bed spray application, or other methods which effectively apply PhycoTerra® to the soil. PhycoTerra® needs to be mixed or agitated to ensure full suspension of product prior to measuring and adding the product to the application mix. Supply tanks and spray tanks should have agitation.

MIX OR AGITATE THOROUGHLY BEFORE USE

STORAGE RECOMMENDATIONS

For best results, it is recommended to keep this product in its original packaging until use. For multiple use, the container should be sealed properly after each use and stored in a dry cool place. Avoid spillage as product may create a slip hazard.

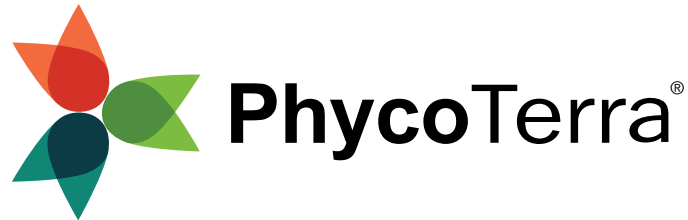

SHAKE / AGITATE THOROUGHLY BEFORE USE

Tighten cap. Firmly holding the handle, flip the jug upside down. Keeping the handle as the pivot point, rock the jug back and forth for 15 seconds.

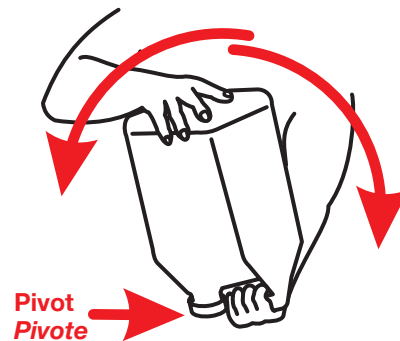
Remove protective seal and use accordingly. Fill the jug with water and cap. Once again use the 'flip and rock' motion above to rinse the jug of any remaining product.
